## EXPLANATORY NOTE

This Registration Statement on Form S-8 (this “Registration Statement”) is being filed by Opus Genetics, Inc. (the “Registrant”) relating to 950,000 shares of its common stock, par value \$0.0001 per share (the “Common Stock”), to be issued pursuant to the Ocuphire Pharma, Inc. 2021 Inducement Plan, as amended (the “Plan”). Pursuant to General Instruction E of Form S-8, the contents of the Prior Registration Statements are incorporated herein by reference and made part of this Registration Statement, except as amended hereby.
